1. You are invited to submit your most competitive quotation for the following goods: -

Sikkim State AIDS Control Society has received a Grant from the Government of India for towards the cost of the National AIDS Control Project (Phase V) and intends to apply a part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations is issued.

3. **BID PRICE**

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- b) All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The prices shall be quoted in Indian Rupees only.

4. Each bidder shall submit only one quotation.

5. **VALIDITY OF QUOTATION**

Quotation shall remain valid for a period of not less than 180 days after the deadline date specified for submission.

6. **EVALUATION OF QUOTATION**

The purchaser shall evaluate and compare the quotations determined to be substantially responsive i.e. which

- a) are properly signed; and
- b) Confirm to the terms and conditions and specifications.
- c) The quotations would be evaluated for all the items together.

7. AWARD OF CONTRACT

The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 7.1 Notwithstanding the above, the purchaser reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to award of the contract.
 - 7.2 The bidder whose bid is accepted will be notified of the award of the contract by the Purchaser prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
8. Payment shall be made immediately after delivery of goods.
09. You are requested to provide your offer latest by 2.30 PM on 23.02.23 in the prescribed format, a copy of which is enclosed.
10. The envelope should be properly sealed and super scribed "**Quotation for OST.**" and the quotation should be dropped in the quotation box, on or before the time and date mentioned in sl. No. 10 above.
11. Quotations will be opened in the presence of the Bidder or their representatives who choose to attend at 2.35 PM on 23.02.23 in the office of the Society at the above address

Additional terms and conditions: -

- a. The manufacturer/supplier should submit certificate of GMP and market standing certificate.
- b. The shelf life should be minimum 3 years from the date of manufacture.
- c. The manufacturer/supplier shall submit the proof of a valid product license congruent to the drugs and cosmetics Act. 1940.
- d. The Buprenorphine Sublingual tablets should be tasteless and odourless.
- e. The manufacturer/supplier shall submit an undertaking of conformance to the rules and regulations laid down in the Narcotic drugs and Psychotropic Substance Act 1985 and its amendments, and the drugs and cosmetics Act. 1940 and the rules thereof. The undertaking should be accompanied with all the relevant documents and certifications.
- f. The Buprenorphine Sublingual tablets should fulfil the general /or individual drug requirements as per Indian Pharmacopoeia 2018 with addendum 2019.
- g. All the blister pack of the Buprenorphine sublingual tab. Must indicate the dates of manufacture and expiry.
